- 494 Phase I project close to design-build award.
- Adjusted Orange Line schedule on December 3 to reflect ridership; will continue to monitor.
- Dakota County is working with MnDOT to start a mini traffic study analysis related to the Hwy 77 mitigation study.
- 169 Corridor Coalition is meeting tonight. Upcoming, there will be three interchange projects led by Scott County, funded primarily through Scott County tax.
- An application for Hwy 13/Nicollet has been submitted to Corridors of Commerce. \$3 million has been earmarked congressionally, and \$10 million from TAB to the City of Burnsville.
- Utility relocation continues for Hwy 13/Dakota Avenue interchange.
