The TAC will connect again and return with suggested changes to projects and edits to the 2025 Legislative Platform. Adding a multi-modal project was also suggested. Joe Gladke and Lisa Freese volunteered to work on Alliance accomplishments and history that could be added to the website.

- 494/35W Interchange scheduled a webinar for the 2025 kickoff, April 15.
- Hwy 169 Corridor Coalition meeting today; prioritization process graphic will be sent out; all three interchange projects under contract and resuming construction in the spring.
- Highway 13 work is underway; open house in December some discussion on separating the project into two; still have \$20-25 million dollar gap in funding.
